The gallery at Ashland Art Center is set up like a traditional gallery, with a cooperative twist! Artists have been selected to exhibit in the showroom on a semi-permanent basis, evaluated every 6 months by the artistic committee.

1. You must be a current member of Ashland Art Center. Membership dues are \$50 per year. This is not waived for gallery artists.
2. Your work will be considered by the jury. Membership in the Art Center does not guarantee exhibition in the gallery.
3. The following criteria determine your eligibility to exhibit:
 - Preparedness to exhibit and quality of work
 - Does not duplicate nor is too similar to artists already in the gallery
 - Ability to create sales
 - Flexibility in range of artwork: size, price, series
 - No mass produced work will be accepted
4. Pricing Standards: Artists who are approved to exhibit in the gallery agree to keep their prices consistent between the gallery and other sale outlets. Reducing your price for outside sales will undermine the sale of gallery items and lessen the value of your art.
5. Outside sales, Commissions or custom work: If art work sells through, or a commission or custom request for any work originates with Ashland Art Center's gallery, website, events or partnerships, past or present, the artist agrees to 75% of the order price with the gallery taking 25% for referral work. If work sells that had no affiliation with Ashland Art Center in any way, past or present, then the artist is entitled to 100% of the proceeds. The artist is responsible for determining how the customer came to find them and uphold the 75/25 agreement.
6. Theft/Damaged Items: Art Center representatives, employees, sponsors and volunteers will exercise the highest degree of care in handling art work, but will not assume responsibility for broken, damaged or stolen property in the art center or at an outside art center event/venue. Artists will not be compensated for broken or damaged artwork. Artists should carry their own insurance to cover their artwork.
7. Termination of Agreement: Either party may terminate this agreement with written notice at any time. Ashland Art Center reserves the right to determine if the working relationship is desirable, as does the artist. Prior notice is not required to terminate this agreement.

Please note: Wall space is very limited. You can be juried in, but you may be placed on a waiting list and notified when wall space becomes available. 3-D artists are likely to be exhibited immediately.

Ashland Art Center is a cooperative gallery, and as such all members are expected to participate financially and to contribute to the working, promotion, and success of the Art Center. Select the level of membership you are applying for:

Work requirements can be met in a variety of ways, by serving on committees or staffing the front counter during business hours. Counter shifts are from 10 a.m. to 2 p.m. or 2 p.m. to 6 p.m.
